Guide for authors (September 2023)

General:

- Submitted articles should have between 5,000 and 15,000 words in length, including footnotes. Submissions that fall short of 5,000 words or exceed 15,000 words will only be accepted when approved by the editor beforehand.
- For each paper, please also send in English a 100-word abstract and 5–10 keywords.
- Articles must be submitted in English, German or French.
- All papers will be subject to further proofreading by the editorial team of Aegyptiaca. This is done by native speakers.

Formatting your document:

- Please use only footnotes and not endnotes. Footnotes should be numbered consecutively and should be placed after punctuation marks.
- Please add acknowledgements between text and bibliography. Please do not place acknowledgements in footnotes at the beginning
- Punctuation should be included within quotation marks only if it is part of the quotation.
- Long-format quotations should be free of external quotation marks and indented flush-left and right 0,5 cm.
- Spelling, punctuation, use of decimals, and other conventions is accepted both UK and US standard, as long as the text is consistent. “Neue deutsche Rechtschreibung (1996)”, must be used, deviations are only accepted if they have been previously approved by the editors.
- For quotes please use “...” and for quotes within quotes ‘...’.
- Interventions in the text by the author are placed in square brackets [...].
- Italics are used for *titles*, *termini technici* or *foreign language terms*, not commonly known.
- Please write out numbers from one to one hundred (except for dates).
- Please use persistent identifiers for Internet addresses. Non-persistent identifiers should be avoided. Add them to the bibliography as digital resources if needed.

Images

- Authors are expected to obtain permission to reproduce any copyrighted materials (e.g. photographs) used in their articles. Supply a list of figures and/or tables, including a caption for each, accompanied by a source line and such acknowledgments as are required.
- Please place image anchors in the text, but do not include the images themselves.
- Image quotations in scientific works are permitted in papers published by *Aegyptiaca*.
- This is due to an amendment to the law in Germany that came into force in Germany on March 1, 2018: new regulation of §51 of the “Gesetzes über Urheberrecht und verwandte Schutzrechte (Urheberrechtsgesetz – UrhG)”.

Quotations in foreign languages

- Single words or short phrases, where essential to the argument, may be left in the original language; all quotations should appear in the body of the text in English (in German for German articles/ French for French articles).
- The text in its original language should appear in the footnotes whenever practical. In cases where standard scholarly translations of quoted texts are available, scholars may rely upon them for both text and footnotes according to the professional standards of their fields of specialization. If such editions are not widely and readily available, and the author has not provided the original text in the footnotes, the author must provide the original texts in an appendix for the reviewers’ use.
- If an article contains extensive blocks of special characters in a non-Latin alphabet, authors need to submit the complete blocks as image files, not in text format.
- Please give a translation of quotation in other languages than German, French or English.

Classical references

- The edition, as well as credit for translation, must be specified the first time a work is cited. You should use standard scholarly editions and translations when they exist for the work in question unless your argument requires otherwise.
- References to information supplied by a modern editor must include page numbers.
- References to the classical text must include the standard identification numbers for that text, such as book and chapter numbers or Stephanus numbers. Use Arabic numbers for all divisions.
- Plato Republic 360E–361B.
- Cicero De officiis 1.133.
- Standard abbreviations may be used.

Copyright, permissions and Open-Access Policy

- It is the author's responsibility to obtain online permission to quote material from thirdparty sources and to cover any costs incurred in securing these rights. The editors should be alerted at the earliest opportunity as to any difficulty in securing these thirdparty rights.
- Authors retain copyright and grant the journal right of first publication with the work simultaneously licensed under a Creative Commons Attribution License that allows others to share the work with an acknowledgement of the work's authorship and initial publication in this journal.
- Authors are able to enter into separate, additional contractual arrangements for the non-exclusive distribution of the journal's published version of the work (e.g., post it to an institutional repository or publish it in a book), with an acknowledgement of its initial publication in this journal.
- Authors are permitted and encouraged to post their work online (e.g., in institutional repositories or on their website) prior to and during the submission process, as it can lead to productive exchanges, as well as earlier and greater citation of published work.

Sample Notes and Bibliography

General: The place of publication should be specified in the form given on the title page.

Books

In the Note

Grazer and Fishman, *Curious Mind*, 37.

Bibliography entries (in alphabetical order)

Grazer and Fishman, *Curious Mind* Grazer, Brian, and Charles Fishman. *A Curious Mind: The Secret to a Bigger Life*. New York: Simon & Schuster, 2015.

Chapter or other part of an edited book

In a note, cite specific pages. In the bibliography, include the page range for the chapter or part.

In the Note

Thoreau, “Walking”, 182.

Bibliography entry

Thoreau, “Walking” Thoreau, Henry David. “Walking”. In *The Making of the American Essay*, edited by John D’Agata, 167–195. Minneapolis: Graywolf Press, 2016.

Translated book

In the Note

Lahiri, *In Other Words*, 184.

Bibliography entry

Lahiri, *In Other Words* Lahiri, Jhumpa. *In Other Words*, translated by Ann Goldstein. New York: Alfred A. Knopf, 2016.

In some cases, you may want to cite the collection as a whole instead.

In the Note

D’Agata, *American Essay*, 182.

Bibliography entry

D’Agata, *American Essay* D’Agata, John, ed. *The Making of the American Essay*. Minneapolis: Graywolf Press, 2016.

Journal article

In a note, cite specific page numbers. In the bibliography, include the page range for the whole article. For articles consulted online, include a URL or the name of the database.

Website content

It is often sufficient simply to describe web pages and other website content in the text (“As of May 1, 2017, Yale’s home page listed ...”). If a more formal citation is needed, it may be styled like the examples below. Please try to use persistent identifiers. If it is not possible, the access date should be included.
